ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the incorporation is organized is:

The purpose of the West Florida Dietetic Association, Inc. is to provide direction and leadership for quality dietetic practice, education, and research and to promote optimal health, nutrition, and well being to the population.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The Board of Directors, also referred to as the Board, shall manage the affairs of the West Florida Dietetic Association, Inc. This Board shall consist of the elected officers: President, President-elect, Secretary and Treasurer. The President shall serve as the Chair of this Board.

The report of the current Nominating Committee shall be made at the March meeting and the election of officers shall be by written ballot mailed by the Secretary to the membership during the month of April. The President-elect and Secretary are elected annually; Treasure elected every two- (2) years. The slate of officers to be elected need not include two names for each office. Ballots shall be marked and returned to the teller by the date specified on the ballot. The Nominating Committee shall appoint the teller. The persons receiving respectively, the largest number of votes for the office of the President-elect, Secretary, and Treasurer, shall be elected to those offices. In the event of a tie, lot shall determine the election.

The President shall be ineligible to succeed himself except that in the event of the vacancy in the office of the President-elect, the President may be eligible to accept a nomination to succeed himself in the office of President. The President-elect shall be ineligible to succeed himself in that office. The Secretary and the Treasure shall be eligible to succeed themselves in those offices.
