Directing and Organizing Network for Education and
Training Community Development, Inc.

ONE: The name address of this principal corporation is **Directing and Organizing Network for Education and Training Community Development, Inc.** **18728 NW 46th Avenue Miami, Florida in Dade county.** The corporation is organized pursuant to the **Florida Nonprofit Corporation Code.**

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The program will consist of education, literacy, amateur athletics and the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. This corporation will also provide housing for lower income individuals and families.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

FIVE: I hereby accept the duties and responsibilities as registered agent.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation, exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code

SEVEN The property of this corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

EIGHT: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Religious, Charitable and Educational purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
