ARTICLES OF INCORPORATION  
OF  
UNITY FOR KIDS EARLY INTERVENTION CENTER, INC.

The undersigned incorporator(s), for the purpose of forming a corporation under the Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation shall be: UNITY FOR KIDS EARLY INTERVENTION CENTER, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on the date of filing with the Secretary of State of Florida, and continuing until dissolved according to Florida law.

ARTICLE III – NON-PROFIT CORPORATION

This corporation is organized exclusively for charitable, and educational purposes. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized to pay reasonable compensation for services rendered to the corporation.

Notwithstanding any other provision of these Articles of Incorporation or By-laws, this corporation shall not carry on any activities not permitted by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code.

ARTICLE IV - PURPOSE

This not-for-profit corporation is organized for the purpose of operating a preschool for children with, and without, varying exceptionalities, and engaging in other lawful related activities permitted under the laws of the United States and the State of Florida.




