Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

Article I and Article VII to be amended as follows:

ARTICLE I. NAME

The name of the corporation is: PALMETTO FAMILY COMMUNITY LIFE CENTER, INC.
