Article I: NAME.

The name of this corporation shall be:

Parents Are Powerful, Inc.

Article II: PRINCIPAL OFFICE.

Article III: PURPOSE.

The purpose for which the corporation is organized is:

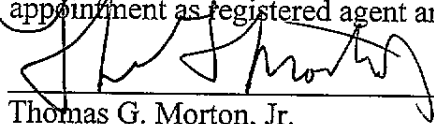

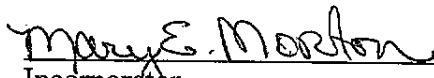
