**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

The name of the Corporation is Vietnamese Catholic Association of Palm Beach, Inc. (Herein called the "Corporation").

**ARTICLE II - PRINCIPAL OFFICE**

The address of the principal office of this Corporation is 6861 Donald Ross Rd, Palm Beach Gardens, Florida 33418

**ARTICLE III - PURPOSES**

The Corporation is organized exclusively for religious, charitable, educational, social welfare and purposes as described in Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of future federal tax code.

No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf or in opposition to any candidate for public office.

Notwithstanding any other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on

- (a) By a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or
- (b) By a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IV - MANNER OF ELECTION/APPOINTMENT**

The powers and duties of directors shall be established by the Bylaws.
