NON PROFIT ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following:

ARTICLE I

ARTICLE II Principle place of business and mailing address

ARTICLE III Purpose(s)

The specific purpose(s) for which this corporation is organized (are): exclusively for church affairs, educational, social and charitable purposes.

ARTICLE IV Limitation of corporate powers

The corporate powers of this corporation are as provided in section 6170302, Florida Statutes; has perpetual duration and succession in the corporate name and has the same powers as an individual to do all things necessary or convenient to carry out the corporate business and affairs, including without limitation of power:

- 1. To sue and be sued, complain and defend in its corporate name;
- 2. To have a corporate seal, which may be altered at will and to use it or a facsimile of it by impressing or affixing it or in any other manner reproducing,

- To make and amend by laws, not inconsistent with the articles of incorporation or with the laws of this state for managing the business and regulating the affairs of the corporation;
- 4. To purchase, receive, lease, or otherwise acquire, and own, hold, improve, use, or otherwise deal with, real or personal property, or any legal or equitable interest in property, wherever located;
- 5. To sell or convey, mortgage, pledge, lease exchange and otherwise dispose of all or any part of the property,
- 6. To purchase, receive, subscribe for or otherwise acquire own hold vote use sell mortgage lend pledge, or otherwise dispose of, and deal in and with shares or other interests in, or obligations of, any other entity;
- 7. To make contracts and guarantees, incur liabilities; borrow notes, bonds, or other obligations (which may be convertible into or include the option to purchase other securities of the corporation), and secure any of its obligations by mortgage or pledge of any of its property, franchises, or income;
- 8. To lend money, invest and reinvest its funds, and receive and hold real and personal property as security for repayment;
- 9. To be a promoter, partner, member, associate, or manager of any partnership, joint venture, trust, other entity;
- 10. To conduct its business, locate offices, and exercise the powers granted by this Act within or without this state;
- 11. To elect directors and appoint officers, employees and agents of the corporation, define their duties, fix their compensation, and lend them money and credit;
- 12. To pay pensions and establish pension plans, pension trusts, profit sharing plans, share bonus plans, share option plans, and benefit or incentive plans for any or all of its current or former directors, officers, employees, and agents;
- 13. To make donations for the public welfare or the charitable, scientific, or educational purposes;
- 14. To transact any lawful business that will aid governmental policy;

15. To make payment or donations, or do any other act, not inconsistent with law, that furthers the business affairs of the corporation.
