**ARTICLES OF INCORPORATION OF
Homeward Bound Foundation, Inc.**

A NOT FOR PROFIT CORPORATION

We, the undersigned do hereby join together in the formation of a non-profit corporation, following the terms and conditions, to wit:

ARTICLE I

This corporation will be entitled Homeward Bound Foundation, Inc., with a principal place of business located at 3540 Bridgewood Dr., Jacksonville, Florida 32277.

ARTICLE II

This corporation is a non-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this organization are to provide charitable and educational services for persons experiencing need, such as health care services, financial assistance, youth services and activities.

ARTICLE III

This corporation will not own any capital stock and the corporation will operate under perpetual terms.

ARTICLE IV

A Board of Directors shall manage the activities and affairs of the corporation. The number of directors which shall constitute the entire board, shall be arranged in the manner set forth in the by-laws of the corporation and/or by Pastoral appointment, but under no circumstances will the board consist of less than (3) members.

ARTICLE V

All meetings of the Board members will be held according to the by-laws.

ARTICLE VI

The books of the corporation may be kept subject to any provisions contained within or outside of the statutes of the State of Florida, at such a place so designated by the Board of Directors.

ARTICLE VII

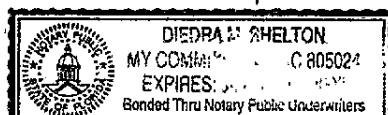
