The undersigned incorporator, for the purpose of forming a corporation under the Florida

Not for Profit Act, here by adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation shall be: **JESUS CHRIST WORSHIP CENTER INC.**
(Hereinafter referred to as the "Ministry").

ARTICLE II. PURPOSE

The Purpose and object of this Ministry shall be to teach and spread the gospel of Jesus Christ, to utilize biblically based methodology in broadcasting, research, counseling and Professional approaches to healing and ministering to the body, mind, and spirit. The Ministry shall also conduct any and all business consistent with the laws of the State Of Florida and United States of America.

ARTICLE III. PRINICPAL PLACE OF BUSINESS

The principal place of business of this ministry shall be 4324 Williamsburg Ave.

ARTICLE IV. TERM OF EXISTANCE

ARTICLE VII. BY-LAWS

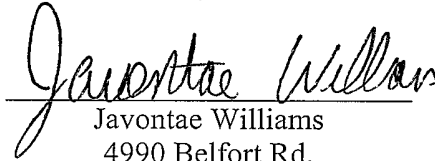
The board of directors shall adopt by a majority vote the original by-laws of the Ministry.
