ARTICLE ONE

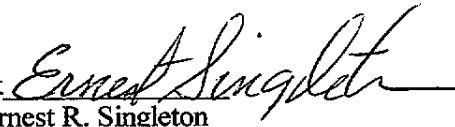

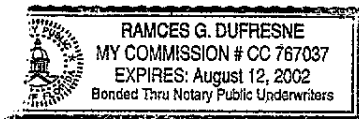

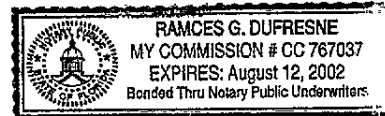
