

# Article I Name

# Article II Principle Office

## Article III Purposes

The purpose of the corporation is to function as a church that will operate in the state of Florida. Evangelism is a key function of the ministry in spreading the good news of the Gospel of Jesus Christ.

# Article IV Manner of Election

- 2. A director can be dismissed by the majority of the board in cases of misconduct that is not appropriate of the Statement of Faith and by-laws of His Presence Glory and Worship Center.
- 3. The death of the director.

The replacement of a Director will be made by appointment. The Board of Directors, in which case a majority vote is required, will select the candidate.
