## ARTICLES OF INCORPORATION

### ARTICLE I. NAME

The name of this corporation shall be His World Ministry, Inc. and the initial principal address of the corporation is 717 East Oak Street, Kissimmee, FL 43744.

### ARTICLE II. DURATION

This corporation shall have perpetual existence commencing on July 16, 2001, unless dissolved according to law.

### ARTICLE III. PURPOSE

This corporation is organized for the purpose of:

1. To propagate the Christian Faith and to spread the Gospel of Jesus Christ as revealed through the Holy Scriptures by all means of communication, whether visual, verbal or written.
2. To provide for preaching, teaching and fostering the growth of the Christian faith in all places; to carry on the work of evangelism; to promote missionary work in all places.
3. To collect, solicit and accept funds, gifts and other subscriptions; to hold in trust, use, mortgage, lease, sell or otherwise acquire or dispose property, real or chattel, in keeping with the recited purposes of this ministry and it shall have and exercise all powers that are necessary or convenient to effect any and all of the purposes for which this ministry is organized.

The specific purposes will not serve to exclude the organization from carrying on any other charitable, religious, educational, or scientific activity permitted under Section 501(c)(3) of the Internal Revenue Code.

### ARTICLE IV. QUALIFICATION

The qualification for members and the manner of their admission are as determined by the Board of Directors and the by-laws of the corporation.

### ARTICLE V. ADDRESS

The initial post office address of the principal place of business of this corporation is 717 East Oak Street, Kissimmee, FL 34744. The Board of Directors may, from time to time, move the principal office to any other address in Florida.

## ARTICLE VI. DIRECTORS
