AMENDMENT SECTION 3 INCORPORATION

KINGDOM EVANGELISTIC MINISTRIES, INC.

The name of the Corporation is Kingdom Evangelistic Ministries Inc. Located in Duval County, Jacksonville, Florida 32254

This corporation is organized and shall be operated exclusively for religious and charitable purposes within the section 501 (c) (3) of the Internal Revenue Code of 1954, or the corresponding provisions of any future United States Internal Revenue law, including the following: The purpose for which this corporation is formed are:

To promote public and private worship; to encourage Christian Fellowship; to Preach and Teach the Word of God, through Christian Education, Bible Study, one on one Counseling, Administer the ordinances of Baptism and Lord Supper; to engage in personal and public Evangelism; and to support Missionary on the Missionary Fields, at home and abroad.

To promote and develop any other type of Religious or Charitable work within the limits and restrictions provided by or under the laws of the State of Florida or any other lawful authority not in conflict therewith.

To engage in community empowerment through Christian based life application training to improve the Financial, Spiritual, and physical condition of any community in which religious services are held.
