# ARTICLES OF INCORPORATION OF PRECEPT PARTNERS OF FLORIDA, INC.

The undersigned incorporator to these articles of incorporation hereby forms a corporation not for profit (the "Corporation") under the laws of the State of Florida articles.

# ARTICLE I Name, Principal Place of Business, and Mailing Address

The name of the Corporation is: Precept Partners Of Florida, Inc. The principal place of business of the Corporation is not presently known, but shall be as provided by resolution duly adopted in accordance with the by-laws of the Corporation. The mailing address of the Corporation is P.O. Box 1832, Winter Park, Florida 32790-1832.

### ARTICLE II Term of Existence

The date when corporate existence shall commence shall be the date of the filing of these articles of incorporation by the office of the Florida Department of State and the Corporation shall have perpetual existence thereafter.

## ARTICLE III Purpose

The Corporation is organized and shall be operated exclusively for educational, religious and charitable purposes for the primary purpose of developing, educating and training inductive Bible study leaders throughout Florida; providing courses, seminars, conferences and workshops in the inductive study method for both Bible study leaders and students; developing and training inductive Bible study teachers in local churches; and supporting mission activities which have as their primary purpose the training of inductive Bible study leaders and students.

The Corporation shall have all powers now or hereafter granted by law, and in addition thereto shall have all powers lawfully necessary or required to carry out its purposes and objects. All of the assets or earnings shall be used exclusively for the purposes hereinabove set out, including payment of expenses incidental thereto. No part of the net earnings shall inure to the benefit of any individual, and no part of its activities shall be for the carrying on of propaganda or otherwise attempting to influence legislation.

#### ARTICLE IV Members

The Corporation shall have members. The By-laws shall prescribe the manner of admission and duration of membership in the Corporation. The initial Board of Directors shall constitute the initial charter members of the Corporation.

## ARTICLE V Initial Registered Office and Agent

The street address of the initial registered office of the Corporation is c/o Carlton Fields P.A., CNL Center at City Commons, 450 So. Orange Avenue, Suite 500, Orlando, Florida 32801-3336, and the name of its initial registered agent at such address is Robert L. Young.

## ARTICLE VI Directors

The Corporation shall have seven (7) directors initially. The number of directors may be increased or decreased from time to time and their election and appointment shall be as specified in By-laws of the Corporation, provided that the Corporation shall always have at least three directors.
