**ARTICLES OF INCORPORATION OF
NAPLES RUGBY CLUB, INC., A NOT-FOR-PROFIT CORPORATION**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a not-for-profit corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Naples Rugby Club, Inc. The principal place of business of this corporation shall be 1720 Wellesley Circle, Naples, FL 34116.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 900 Sixth Avenue South, Suite 201, Naples, Florida 34102, and the name and address of the initial registered agent of the corporation at that address is Eric J. 




