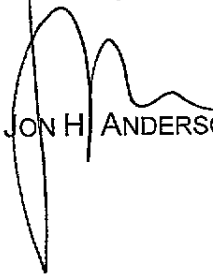

**ARTICLES OF MERGER**

Pursuant to Fla. Stat. 608.438, the Charger Youth Football League, LLC (the "LLC"), a Florida limited liability company, and Charger Youth Football League of Lakeland, Inc. (the "League"), a Florida corporation not for profit, adopt these Articles of Merger for the purpose of merging the two entities into one corporation not for profit to be known as Charger Youth Football League of Lakeland, Inc.

**ARTICLE I**  
**CONSTITUENTS**

The parties to this Merger are as follows:

A. Charger Youth Football League, LLC, a Florida limited liability company, was originally organized in Florida on September 28, 2000. *L- 11780*

B. Charger Youth Football League of Lakeland, Inc., a Florida corporation not for profit, was originally incorporated in Florida on July 23, 2001. *Not- 5217*

**ARTICLE II**  
**SURVIVING CORPORATION**

Charger Youth Football League, LLC shall be merged into Charger Youth Football League of Lakeland, Inc. Charger Youth Football League of Lakeland, Inc. shall be the surviving entity. After the merger Charger Youth Football League of Lakeland, Inc. shall continue to be organized and incorporated under Chapter 617, Fla. Stat.

**ARTICLE III**  
**PLAN OF MERGER**

The Plan of Merger attached to these Articles of Merger as Exhibit "A" was adopted by each of the constituents as follows:

A. The only member of Charger Youth Football League, LLC, is The Carpenter's Home Church, Inc. (the "Church"), a Florida corporation not for profit. Charger Youth Football League, LLC, adopted the Plan of Merger in accordance with its Articles of Incorporation and Bylaws on July 30, 2001.

B. The initial sole director of Charger Youth Football League of Lakeland, Inc. adopted the Plan of Merger on July 30, 2001, in accordance with the Articles of Incorporation and Bylaws of Charger Youth Football League of Lakeland, Inc.

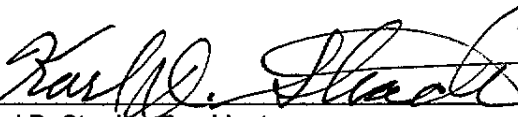

**ARTICLE IV  
EFFECT OF MERGER**

All legal obligations of Charger Youth Football League, LLC, and Charger Youth Football League of Lakeland, Inc., shall be considered obligations of Charger Youth Football League of Lakeland, Inc. after this merger.

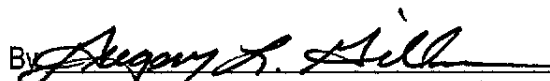

**PLAN OF MERGER  
OF  
CHARGER YOUTH FOOTBALL LEAGUE, LLC.  
AND  
CHARGER YOUTH FOOTBALL LEAGUE OF LAKE LAND, INC.**

1. Parties: The parties to this Plan of Merger are Charger Youth Football League, LLC, a Florida limited liability company (the "LLC") and Charger Youth Football League of Lakeland, Inc., a Florida corporation not for profit (the "League").
2. Intention: This Plan of Merger is intended to fulfill the requirements of Fla. Stat. 608.438. If adopted by the LLC and the League, this Plan of Merger is intended to accomplish the merger of the LLC and the League in accordance with Florida law. The parties intend that the League shall be the surviving entity after merger. The surviving corporation shall be known as Charger Youth Football League of Lakeland, Inc.
3. Expenses: The League shall pay all of the expenses of the adoption and implementation of this Plan of Merger.
4. Effective Date: This Plan of Merger shall be effective as of the date of filing with the Florida Department of State.
5. Changes in Articles of Incorporation: After the adoption of this Plan of Merger, the surviving entity shall be governed by the Articles of Incorporation and Bylaws of the Charger Youth Football League of Lakeland, Inc., as they exist on July 30, 2001.
6. Creditors Protected: This Plan of Merger is not intended to affect any lien, encumbrance or security interest in effect prior to the effective date. The interests of creditors of the LLC and the League are not affected by the merger of the LLC and the League in any way.
7. Further Action: The officers of the LLC and the League are authorized and empowered to take such additional steps as may reasonably be required to document the merger of the LLC and the League and to give full effect to this Plan of Merger.
