**ARTICLES OF INCORPORATION  
OF  
MUSLIM LADIES ASSOCIATION OF CENTRAL FLORIDA, INC.**

The undersigned subscriber to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves to form a nonprofit corporation under the Laws of the State of Florida.

**Article I NAME**

The name of this nonprofit corporation shall be Muslim Ladies Association of Central Florida, Inc.

**Article II PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation shall be 4564 Thornlea Road, Orlando, Florida 32817-1241

**Article III PURPOSES**

This nonprofit corporation is organized for charitable and educational purposes consistent with Section 501©(3) of the Internal Revenue Code of 1954 as amended from time to time or any equivalent section of the Internal Revenue Code in effect at that time. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.


