**Articles of Incorporation**

The undersigned acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following articles for such corporation.

**Article I**

The name of the corporation is: Destiny People Worship Center, Inc. and the initial principal address of the corporation is: P.O. Box 582 Glen St. Mary, FL. 32040-582

**Article II**

The period of duration of this corporation is perpetual, unless dissolving according to law. Corporate existence shall commence upon filing with the Secretary of State.

**Article III**

The purpose or purposes for which the corporation is organized are to establish a Christian Church for the worship of Almighty God and His Glorious Son Jesus Christ, to produce recordings of music and preaching on both audio, and video, to own and operate T.V., Radio, and Internet Ministries, to produce books and teaching manuals, to ordain ministers and missionaries, to start new churches, to establish ministry training centers to teach and train ministers, and to carry out any and all activities pertaining to the functions of a Christian Church.

**Article IV**

The qualifications for members and the manner of their admission are provided for in the by-laws.

**Article V**

The street address and city of the initial registered office of the corporation is: 7340 Woodlawn Rd. MacClenny, FL. 32063 and the name of the registered agent as such address is: M. David Ragan Jr.

**Article VI**


