The number of Directors constituting the initial Board of Directors is **THREE (3)** and the names of the persons who shall serve as Directors are:

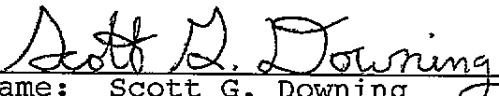
