ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida statutes, adopts the following Articles of Incorporation

Article I

The name of the corporation shall be: PUDH, Inc.

The principal place of this corporation is: 793 NE 125th Street, Miami Fl. 33161

Article II

The period of the duration of this corporation is: perpetual.

Article III

The purposes for which the corporation is organized are to educate and guide the people of Haiti to Economic empowerment and to facilitate economic and sociocultural relations among Haitians in The diaspora.

Article IV

The qualifications for the members and the manner of their admission are any person, firm, partnership, association or any entity is eligible as long as he/it accepts the objectives of PUDH, fills out an application and pays the appropriate fees.

Article V
