ARTICLES OF INCORPORATION

FOR _____

RIVERSIDE PRESBYTERIAN CHURCH OF DAYTONA BEACH, FLORIDA, INC.

The undersigned, acting as incorporators of a non-profit corporation pursuant to Chapter 617, *Florida Statutes*, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: Riverside Presbyterian Church of Daytona Beach, Florida, Inc.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be: 801 N. Halifax Avenue, Daytona Beach, FL 32118

ARTICLE III - PURPOSE

The purpose is to establish a Presbyterian Church in Daytona Beach which will be a Christ centered church faithful to the teachings of the Holy Bible and in accordance with the theology and form of government of the Presbyterian Church (U.S.A.). All active members of the Church shall be members of the corporation.

ARTICLE IV - MANNER OF ELECTION OF TRUSTEES

The number of Trustees shall be the number of active elders of the Church in active service.

The manner in which the Trustees are elected or appointed is as follows:

The Trustees shall be elected by virtue of their election as Elders in accordance with provisions of the Book of Order of the Presbyterian Church (U.S.A.). Officers shall be a president, vice president, secretary, and treasurer and such other officers as the Trustees may elect.

ARTICLE V - LIMITATION OF CORPORATE POWERS

The powers of the corporation shall be as provided in Sec. 617.0302, *Florida Statutes*, except that any real property owned by the corporation shall be not

mortgaged, encumbered, or sold without the express consent of the Congregation and subject to the approval of Central Florida Presbytery or its successors. All real and personal property shall be considered to be held in trust for the Presbyterian Church (U.S.A.) and in the event of dissolution all such property shall be distributed to and vested in the Central Florida Presbytery or its successors on liquidation.

ARTICLE VI - INITIAL REGISTERED AGENT AND STREET ADDRESS
