

ARTICLE I

Name

The name of this corporation is CENTER OF SPIRITUAL AWARENESS, INC. and said corporation is organized pursuant to Chapter 617, Florida Statutes, as amended.

ARTICLE II

Duration

The term of existence of this corporation is perpetual. The corporate existence will commence on July 13, 2001.

ARTICLE III

Purpose

The general purpose of this corporation is to provide an organization for religious purposes, and to do all things allowable and permitted in accordance with the laws of the United States and pursuant to Chapter 617.021 of the Florida Statutes, as amended from time to time, and is not for the purposes of pecuniary profit.
