ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes adopt(s) the following articles of incorporation for such corporation.

ARTICLE I

The name of the corporation is:

ARTICLE II

The period of duration of this corporation is:

"Perpetual", unless dissolved according to the law.
Corporate existence shall commence upon "Filing with the Secretary of State".

ARTICLE III

The purpose or purposes for which the corporation is organized are:

For the purpose of establishing and maintaining a place for the worship of Almighty God, or heavenly Father; to provide for Christian fellowship for those of like precious faith, where the Holy Ghost may be honored; to assume our share of responsibility and privilege of propagating the gospel of Jesus Christ by all available means, both at home and aboard. This church shall have the right to govern itself according to the standards of the New Testament Scriptures.

Article III continues

It shall have the right to teach religious and sound doctrine of Jesus Christ, to establish and maintain places of worship in accordance with the traditions, rites and practices of Jesus Christ; establish churches of the Doctrine of Jesus Christ religion in other counties of the State of Florida, in other states of the United States of America and in other countries of the World; establish, maintain and conduct a school of General Education, Natural Healing, Religion and Instruction for children and adults, known as Christian Development, which will give full academic degrees and provide courses of religious and instruction in natural healing and spiritual development; prepare individuals and qualify them to be ordained into the Body of Christ as Ministers, Deacons, Missionaries, Youth Ministers, Evangelists, Elders, and Musicians; provide a council where disputes between members of the establishment, can be resolved with justice and impartiality; provide a means by which like-minded people may unite with the idea of true freedom of religion; establish a community of like-minded people who will have similar religious beliefs; and exercise any, all and every power to which an establishment of religion is entitled. It shall have the right to purchase or acquire by gifts, bequest or otherwise wither directly or as trustee, to own, hold in trust, use, sell, convey, mortgage, lease or otherwise dispose of any real estate or chattels as may be necessary for the furtherance of its purposes.

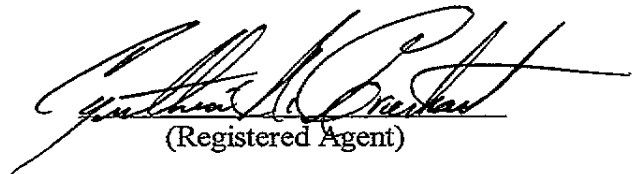

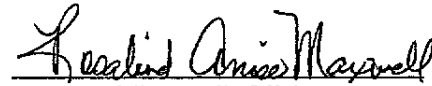
