**ARTICLE I. NAME**

The name of this corporation is WANDUK YACHAI, INC.

**ARTICLE II. DURATION**

The corporation shall have perpetual duration.

**ARTICLE III. PURPOSE**

The corporation is a not for profit corporation. The general purposes for which this corporation is organized are:

(a) To provide aid and financial assistance to educational, health-care, environmental monitoring and restoration, and programs promoting multiculturalism and biodiversity, based on knowledge, tradition, science, experience, and wisdom of the indigenous peoples and directly led by them.

(b) The general purposes for which this corporation is formed are to operate exclusively for such purposes as will qualify it as an exempt organization under Section 501(c)3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualified as tax-exempt organizations under that Code.

(c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene by publication or

distribution of any statements or otherwise, in any political campaign on behalf of any candidate for public office.

#### ARTICLE IV - STOCK

The corporation is organized upon a nonstock basis as defined in Section 617.011 of the Florida Statutes. The corporation shall have a membership distinct from the board of directors. The authorized number and qualifications of members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability for dues and assessment and the method of collection thereof, shall be regulated in the bylaws.

#### ARTICLE V - PRINCIPAL OFFICE

The address of the principal office of this corporation is 848 E. College Avenue #1, Tallahassee, FL 32301 and the mailing address of this corporation is P. O. Box 1742, Tallahassee, FL 32302.

#### ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 848 E. College Avenue #1, Tallahassee, FL 32301 and the name of the initial registered agent of this corporation at that address is Dubravko Kakarigi

#### ARTICLE VII. INITIAL BOARD OF DIRECTORS

This corporation shall have three (3) directors initially. The number of directors may be either increased or diminished from time to time by the bylaws, but shall never be less than three.

#### ARTICLE X. LIMITATIONS

Subject to the limitations contained in the bylaws and any limitations set forth in the Not For Profit Corporation Act of Florida described above, concerning corporate action that must be authorized or approved by the members of the corporation, the bylaws of this corporation may be made, altered, rescinded, added to, or new bylaws may be adopted, either by a resolution of the board of directors or by following the procedure set forth therefor in the bylaws.

#### ARTICLE XI. PROPERTY

The property of this corporation is irrevocably dedicated to providing aid as set forth in Article III hereof and no part of the net income or assets of this corporation shall ever inure to the benefit of any directors, officer, or member thereof, or to the benefit of any individual.

#### ARTICLE XII. DISSOLUTION

Upon dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively in accordance to the general purpose as set forth in Article III hereof and which has established its tax exempt

status under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws or any comparable regulations in other jurisdictions.

ARTICLE XIII. AMENDMENTS

This corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation, or any amendment thereto, and any right conferred upon the members is subject to this reservation.
