# **ARTICLE OF NOT FOR PROFIT INCORPORATION**

**OF**

**EACH ONE HELP ONE FOUNDATION, INC.**

## **ARTICLE I**

### **NAME**

The name of this not for profit corporation is:  
**EACH ONE HELP ONE FOUNDATION, INC.**

## **ARTICLE II**

### **PRINCIPAL OFFICE**

## **ARTICLE III**

### **PURPOSE**

The purpose for which the Not for Profit Corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the General Corporation Act of the State of Florida. This Not for Profit Corporation is assemble for the sole purpose of organizing a charitable foundation to raise funds to build grants to be distribute to organizations, people, or persons in need. The goal is to help in the field of Aids, Cancer, Sickle Cell Research and other needed helpful endeavors. Through fund raising through promotional events and raffles. These shall include but not limited to, the power to sue and be sued, complain and defend in its Not for Profit Corporate name in all actions and proceedings, and to have a Not for Profit Corporate Seal. The Not for Profit Corporation may also purchase, take, receive,

lease, or otherwise acquire, own, hold improve, use or otherwise deal in our or personal property or any interest therein wherever situated. It shall have the power to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of any or all of its property, franchises and income. It may conduct its business, carry on its operations, and have officers and exercise the powers granted by this act within and without the State of Florida.

It may elect and/or appoint officers and agents and define their duties and fix their compensation. It may take and alter by-laws in any way consistent with these Articles of Incorporation and the laws of the State for the administration and regulations of the affairs of the Not for Profit Corporation. The Not for Profit Corporation shall have power to make donations to the public welfare or charitable, scientific, or educational purposes. It shall have the power to transact any lawful business which the Board of Directors shall find to be in aid of Government Policy. The Not for Profit Corporation shall further have the power to pay pensions and establish pension plans, and incentive plans for any and all of its Directors, Officers and Employees and for any and all the Directors, Officers, and Employees of its subsidiaries. It may be promoter, incorporator, general partner, member, associate or manger of any corporation, partnership, limited partnership, joint venture, trust or enterprise. The Not for Profit Corporation shall have the further power to purchase, take, receive, subscribe for, or otherwise use and deal in and with shares or other interest in or other interest in or obligations of other domestic and foreign corporations, associations, partnerships, and individuals including the direct and indirect obligations to the United States or any other government, state, territory, or other governmental body. The Not for Profit Corporation

shall have the power to have and to exercise all powers necessary or convenient to effect its purpose.

## **ARTICLE IV**

### **MANNER OF ELECTION**

The governing Board of this not for corporation shall be known as its Directors. The Directors need not be Stockholders of the not for profit corporation unless so required by the Bylaws. The Board of Directors shall be elected at their annual meeting, or such other time as the Bylaws may provide, and shall hold office until their successors are respectively elected and qualified. The Bylaws shall specify the number of Directors necessary to constitute a quorum. The Board of Director may, by resolution(s) passed by a majority of the whole Board, designate one or more committees which to the extent provided in said resolution(s) or in the Bylaws shall have and may exercise all powers of the Board of Directors on the management of the activities and affairs of the not for profit corporation and may have power to authorize the seal of the not for profit corporation to be fixed to all papers which may require it; and such committee(s) shall have such name(s) as may be stated by the Bylaws of the not for profit corporation or as may be Directors may elect such Officers as the Bylaws may specify, who shall, subject to the provisions of the Statutes, have such titles and exercise such duties as the Bylaws may provide. The Board of Directors is expressly authorized to make, alter, or repeal the Bylaws of this not for profit corporation or any article therein.

The number of Directors may from time to time be increased or decreased in such a manner as shall be provided by the Bylaws of this not for profit corporation,

providing that the number of Directors conform to the Statutes of the Not for Profit Corporation Law of this state.

The initial Board of Directors shall consist of one (1) in number. The name(s) and post office address of each person(s) who are to serve as Director(s) until the first annual meeting of the Stockholders, or until their successor(s) are elected and qualified are:
