**ARTICLES OF INCORPORATION**

**Of**

**FIRE OF THE SPIRIT, INC.**

A Florida "Not for Profit" Corporation

The undersigned, acting as officers of a corporation, FIRE OF THE SPIRIT, INC., under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of the corporation shall be: FIRE OF THE SPIRIT, INC., hereinafter referred to as the "Corporation."

**ARTICLE II**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 838 Alhambra Avenue, St. Augustine, Florida 32086.

**ARTICLE III**

**PURPOSE**

The specific purposes for which the Corporation is organized are exclusively charitable and educational and consist of the following:

- a. To provide independent Bible study meetings, according to Ephesians 4:12 & 13 (Amplified Bible): *"for the perfecting and the full equipping of the saints (His consecrated people) that they should do the work of ministering toward building up Christ's body, the church. That it might develop until we all attain oneness in the faith and in the comprehension of the knowledge of the Son of God, that we might arrive at really mature manhood, the measure of the stature of the fullness of the Christ and the completeness found in Him."*
- b. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purpose, either directly or indirectly, and either alone or in conjunction or cooperation with others. The Corporation, Fire in the Spirit, Inc., is free in Christ and is not a member of any policy making convention and does not come under the oversight of any organization, biennial conference, General Conference, General Board of Administration, society, diocese, Bishop, missionary society or conference, council of churches, alliance of any other council or policy making conference. The term of this corporation shall be perpetual.

- c. All of the foregoing purposes shall be exercised exclusively as charitable and educational purposes in such a manner that the Corporation will qualify as an exempt organization under Section 501© of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

#### **ARTICLE IV** **BOARD OF DIRECTORS**

The affairs of this corporation shall be managed by a Board of Directors. The officers of the Board of Directors shall be a president, a vice-president, and a secretary-treasurer chosen by the Board from their own number. The method of selection of the Board of Directors and number of directors shall be stated in the Bylaws.

**ARTICLE VIII**  
**501(c) LIMITATIONS**

- a. **Corporate Purposes:** Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501(c) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- b. **Exclusivity:** The Corporation is organized exclusively for charitable and educational purposes.
- c. **No Private Inurement:** The Corporation is not organized nor shall be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits or dividends to the Directors, Officers, or members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out the Corporation's charitable, purposes. The property, assets, profits, and net income of the Corporation are irrevocably dedicated to charitable and educational purposes no part of which shall inure to the benefit of any individual.
- d. **Lobby and Political Campaigns:** No substantial part of the activities of the Corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
- e. **Dissolution:** Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c) of the Internal Revenue code of 1986 to be used exclusively for charitable and education purposes. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.

*Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.*

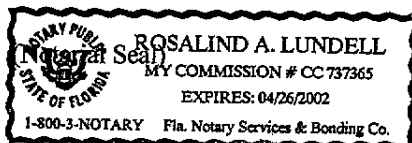
