**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION  
OF ANILA SARSWATI AND PARMANAND VIJAY POONAI  
CHARITABLE FOUNDATION**

Pursuant to the provisions of Section 617.1006, Florida Statutes, the Anila Sarswati and Parmanand Vijay Poonai Charitable Foundation, a Florida Not For Profit Corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article IX of the Articles of Incorporation shall be amended to add the following:

"F. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

G. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code)."

2. The following new Article shall be added:

"ARTICLE 16. Dissolution. Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or shall be distributed to the Federal, State or Local Government for a public purpose."

3. The date of said amendments adoption is December 1, 2001.

4. This amendment was approved by all of the Directors of the Anila Sarswati and Parmanand Vijay Poonai Charitable Foundation. There are no members.
