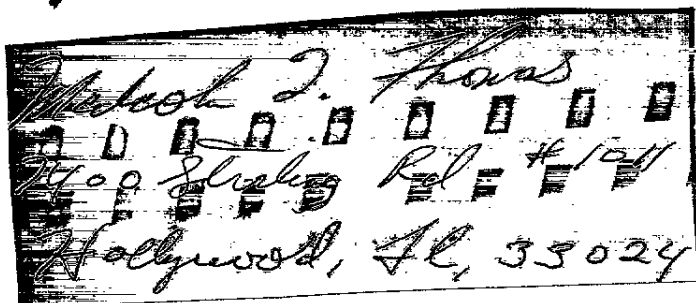

In Compliance with Chapter 617, Florida Statutes (F. S.), (Not for Profit)

ARTICLE I NAME:

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized are:

To provide the necessary job skills, training, coaching, and mentioning to both the individual and / or family.

To provide the necessary support aides and incentives to empower the economic disadvantage in the community in order to promote growth, stability and home ownership.

To provide child care services, support aides and coordinate other community resources to both the individual and / or family.

To assist and support other 501 (c) 3, and other tax exempt not for profit organization with same or similar objectives.

To provide a comprehensive intervention task force of individuals and resources for juveniles before he or she enter the juveniles courts system.

To provide other alternative structures for juveniles already in the courts system, so that he or she can quickly rejoin the community in a constructive and positive active manner.

ARTICLE IV MANNER OF ELECTION
