The undersigned subscriber to these Articles of Incorporation, a natural person to contract, hereby forms a corporation under the laws of the State of Florida, in compliance with Florida Statute Chapter 617 (Not for Profit).

ARTICLE I. NAME

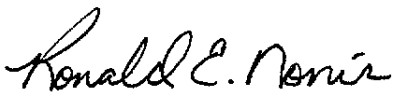
