ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt (s) the following Articles of Incorporation:

ARTICLE I NAME

ABUNDANT LOVE PROPHETIC MINISTRIES INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The Abundant Love Prophetic Ministries is organized to provide a place for the worship of Almighty God, our Heavenly Father; to provide Christian fellowship for those of like faith, where the Holy Ghost may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propogating the Gospel of Jesus Christ by all available means, both at home and in foreign lands. Abundant Love will provide wholistic community outreach services to economically disadvantaged individuals and families within the high risk communities in the crime ridden areas of Tampa. Service provision is designed to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The Board of directors shall be no less than three (3) in number and serve the organization during their five year term as long as their duty is performed consistent with the organization's By-laws but may resign at any time or be removed with or without cause by a majority vote of the Board of Directors. Any resignation or removal shall be in writing and shall become a part of the records of the organization. Directors are appointed after nominations and recommendations are officially submitted in writing to the Board. After a review and discussion by the majority of the Board of Directors of the nominations and recommendations, received, the appointments are made by the Board majority.


