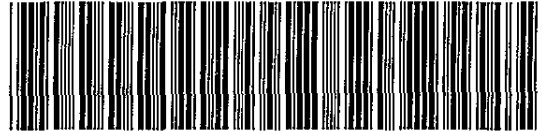



TO ARTICLES OF INCORPORATION
US WOMEN HELP COALITION FAITH-BASED INC.

ARTICLE V. (amended)

The purpose for which the corporation is organized is exclusively for religious, educational, charitable and scientific purposes that are described in Section 501 (c) (3) of the Internal Revenue Code of 1986 as it is currently and shall hereafter be enforced and effect (or the corresponding provision of any future United States Internal Revenue Law)

1. To provide national, state and local meetings, seminars, workshops forums and conferences to address families needs.
2. To develop collaborative cooperation with local, national and international ministries.
3. To establish the new life Christian counseling centers.
4. To provide Christian individual, family and group counseling services
5. To promote individual and family emotional, spiritual and social stability.
6. To provide Christian counseling services at low cost, according to the center sliding scale fees.
7. To provide programs to improve healthy marriages based on Christian faith.
8. To work with government agencies and other social community problems agencies.
9. To provide programs which will prevent recidivism.
