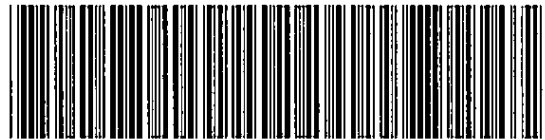

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

**Article I: Name**

The name of the corporation is THE MINISTRY CENTER, INC., a Florida not for profit corporation, document number N01000005528 (hereinafter referred to as the "Corporation").

**Article II: Adoption and Text of Amendments**

Pursuant to Article IX of the Articles of Incorporation and Section 617.1002 of the Florida Statutes, on April 14, 2021, the Board of Directors and all members unanimously voted to approve a Resolution amending Article III and Article IX of the Articles of Incorporation. The following is a true and correct copy of the Resolution amending Article III and Article IX of the Articles of Incorporation.

**Article IV: Amendment to Article IX**

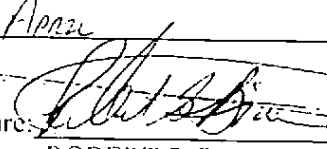
RESOLVED, that Article IX of the Articles of Incorporation of the Corporation be amended in its entirety to read as follows:

INCORPORATION AND BY-LAWS**

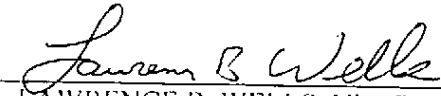
