The name of the corporation shall be ASSOCIATION DES EGLISES

This corporation shall have perpetual existence.

ARTICLE III. - PURPOSE

The particular business and objects for which this corporation is formed are for  
the purpose of diffusing moral and religious knowledge throughout the entire state by  
means of churches, community service centers and youth centers.

ARTICLE IV. - MEMBERS

The membership of the association shall consist of duly elected representatives  
from the different Adventist Haitian churches in the state of Florida and the members of  
the board of trustees.

This corporation shall have no capital stocks and no portion of the income, gains,  
profits or assets of the corporation shall be paid or distributed directly or indirectly to any  
member of the corporation nor shall any of the gains, income profit or property of the  
corporation insure to the benefit of any member of the corporation.


ARTICLE VIII.- CORPORATE POWERS
