We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of the corporation shall be:
FORGOTTEN COAST RURAL HEALTH NETWORK, INC.

ARTICLE II.

The address of the principal office of this corporation shall be 135 Avenue G, Apalachicola, Florida 32320 and the mailing address shall be the same.

ARTICLE III.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to plan and deliver health care services on a cooperative basis in rural areas, except for some secondary and tertiary care services. The corporation is to exist perpetually.

ARTICLE IV.

The manner in which the directors are to be elected or appointed is by election as stated in the bylaws.

ARTICLE V.

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation.
