The undersigned hereby executes and files this First Amendment To Articles of Incorporation of Redland Citizens Against Incorporation, Inc., which Articles of Incorporation are hereby amended as follows effective August 3rd, 2001:

1. The name of this Corporation is Redland Citizens Against Incorporation, Inc.
2. Article I of the Articles of Incorporation of Redland Citizens Against Incorporation, Inc. are hereby amended to provide that the name of this Corporation shall be Citizens Against Redland Incorporation, Inc.
3. The foregoing Amendment is effected by the undersigned initial Secretary, effective as of August 3, 2001 for the purpose of correcting an error in the stated name contained in the original Articles of Incorporation, which Amendment was effective prior to the date adoption by the members of the Corporation was required, and which Amendment was unanimously ratified by members of the Board of Directors.
4. As of the effective date of this Amendment there were no members entitled to vote. This Amendment was adopted by the Board of Directors of August 3, 2001.
5. Except as otherwise provided herein, the Articles of Incorporation shall remain in full force and effect.
