## ARTICLES OF INCORPORATION

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Law of section 501(c)(3) of Internal Revenue Code, do hereby certify:

**FIRST**: The name of the Corporation shall be The Connection Parent Organization, Inc.

**SECOND:** The place in this state where the principal office of the Corporation is to be located is the City of Miami, Dade County.

**THIRD:** Said Corporation is organized exclusively for charitable, religious, educational, or scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
