ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, here adopt(s) the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be: Words From Heaven Ministries and Education Center, Inc.

ARTICLE II

ARTICLE III

The specific purposes for which this corporation is organized are:
