

ARTICLE 1

The name of this Not for Profit Corporation shall be:

ARTICLE III

The general purpose for this not for profit corporation is organized to establish and operate a not for profit church. For these purposes this corporation may engage in any activity and exercise any power of authority that may be engaged in by a non-profit corporation organized under Chapter 617, Florida Statutes, as amended.

ARTICLE IV

The number of Directors constituting the initial Board is six (6). The number of Directors may be either increased or diminished from time to time in accordance with the Bylaws but shall never be less than three (3). The Board of Directors are elected according to the provisions of the Bylaws.

ARTICLE V

This corporation shall issue no stock. No part of the net earnings of this corporation shall inure to the benefit of or shall be distributed to its members, directors, or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in this article. Notwithstanding any other provision of these articles, this corporation shall not carry on any activities deemed impermissible for corporations exempt from the federal income tax under Section 501 (c) 3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law or by a corporation, contributions to which are deductible under Section 170 (c) 2 or the corresponding provision of any future United States Internal Revenue law. On the dissolution of this corporation the board of directors shall dispose of all the assets of the corporation exclusively for the purposes of this corporation in the manner or to organizations that are organized and operated

exclusively as exempt organization in Section 501 (c) 3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or after paying or making provision for the liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is located. Such court of competent jurisdiction shall dispose of the assets of this corporation to organizations that are organized and operated exclusively for charitable, educational, or scientific purposes.
