**ARTICLES OF INCORPORATION**  
**OF**  
**THE FATHER'S COMPANY, INC.**

A FLORIDA CORPORATION NOT FOR PROFIT

In order to form a corporation in accordance with the provisions of the laws of the State of Florida for the formations of corporations not for profit, Chapter 617, Florida Statutes, the undersigned, hereby as Incorporator, designates the Articles for the purposes and with the powers hereinafter mentioned.

**ARTICLE I**

CORPORATION NAME. The name of this corporation is:

**"THE FATHER'S COMPANY, INC."**

**ARTICLE II**

PRINCIPAL OFFICE. The principal place of business shall be:

**ARTICLE III**

PURPOSES. The purpose for which the corporation is organized is:

(a) To form a Christian performing arts company for the purposes of spreading the gospel of Jesus Christ through the art of dance, drama, music and fine art. To encourage all the members of the performing company to commit themselves to participate actively in classes, rehearsals and ministry performances and to develop the character of Jesus Christ.

(b) To offer classes for instruction not only in various styles of the Arts, using both classical and Christian music, but how to use their artistic gifts to worship God. Classes for instruction will be offered to both male and female and there will be a schedule of regular days and hours for these classes. Separate classes will be held for Company members. The specific purpose for all class instruction is to teach the students to worship Jesus and minister on His behalf with their individual talents and gifts.

(c) Anyone desiring to be a part of the performing Company must audition and be approved by the Company directors. There will be no discrimination because of race, age, or financial status. We do, however, reserve the right to choose those who are of like-kind of faith and moral principles because it is a Christian Performing Company.

(d) Our ministry performances will be held in such places as, but not limited to, homes for the aged, schools (both public and private), churches, festivals, rehabilitation centers, community events and private functions, etc. All will be done for the purpose of promoting the gospel of Jesus Christ and not just entertainment.

(e) No part of the net earnings of the corporation shall personally benefit or be distributable to any officer, director or instructor, except that the corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

(f) To do any and all things and exercise any and all powers, rights and privileges consistent with its purposes which a Florida corporation not for profit may now or hereafter be organized to accomplish under the Florida Not For Profit Corporation Act or any Act amendatory thereof, supplemental thereto, or in substitute thereof.

#### ARTICLE IV

MANNER OF ELECTION. The method in which the directors are elected or appointed is as stated in the bylaws. Each person named in the Articles of Incorporation at its organizational meeting as a member of the Board of Directors shall be the initial Board.

The approval of a majority vote of the Board of Directors must be given in order that any additions or removals take place. All directors and/or officers shall hold their offices as long as they remain members of this Corporation unless removed from cause of early resignation, death or removal by a majority vote of the Board. The Board of Directors shall appoint the officers and the officers shall serve at the pleasure of the Board.
