ARTICLES OF INCORPORATION

Notice is hereby given that the undersigned incorporators, all being of full age, have associated themselves together for the purpose of forming a corporation not for profit, without capital stock, under the provisions of Chapters 607 and 617, Florida Statutes and we do hereby accept all of the rights, privileges, benefits and obligations conferred and imposed by said law, and we do hereby make, subscribe, acknowledge and file these Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation is Sister Cities of Sunrise, Inc.

ARTICLE II

GENERAL AND SPECIFIC PURPOSES

- (a) The specific and primary purposes for which this Corporation is formed are to operate for the aid, assistance and advancement of all lawful purposes for which it may act.
- (b) The general purposes for which this Corporation is formed are to operate exclusively for such purposes as may or may not qualify it as an exempt organization under Section 501 (c) (3) of

the Internal Revenue Code of 1986 or corresponding provisions of any subsequent Federal Tax Laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.

- (c) In addition, the objects and purposes for which this Corporation is established shall be in the furtherance in hand of such purposes as well as the following purposes:
- (1) To cause the people of the City of Sumrise, Florida and the people of cities outside of the United States of America, as may from time to time be determined by the members of the Corporation, to a consciousness of each other, to understand one another as individuals, as members of their community, as citizens of their country and as part of the family of nations.
- (2) To foster as a result and consequence of such knowledge and consciousness, a continuing relationship of mutual concern between the people of the City of Sunrise, Florida and the peoples of the cities outside of the United States of America as from time to time determined by the Corporation.
- (3) To participate as an organization in the promoting, fostering and publicizing state and national programs of international municipal cooperation organizations, and thereby to encourage other organizations and residents of American communities to engage and participate in such programs, to foster and promote friendly relations and mutual understanding between peoples of this American community and peoples of the friendly nations outside of the United States of America, and to act as a coordinating body.

(4) Provided that the association shall not in any way, directly or indirectly, engage in the carrying on of propaganda or otherwise attempt to influence legislation.

ARTICLE III

CORPORATE POWER

In addition to all other corporate powers provided by law, and in furtherance of the objectives described above, but not in limitations thereof, the Corporation shall have the power to:

- (a) Have succession by its corporate name for the period set forth in its Articles of Incorporation;
- (b) Sue and be sued and appear and defend in all actions and proceedings in its corporation name to the same extent as a natural person;
- (c) Adopt and use a common corporate seal and alter the same; provided, however, that such seal shall always contain the words "corporation not for profit";
- (d) Elect or appoint such officers and agents as its affairs shall require and allow them reasonable compensation;
- (e) Adopt, change, amend and repeal bylaws, not inconsistent with law or its Articles of Incorporation, for the administration of the affairs of the corporation and the exercise of its corporate powers;
 - (f) Increase, by a vote of its members cast as the bylaws may

direct, the number of its directors, managers or trustees so that the number shall not be less than three (3) in number;

- (g) Make contracts and incur liabilities, borrow money at such rates of interest as the Corporation may determine, issue its notes, bonds and other obligations, and secure any of its obligations by mortgage and pledge of all or any of its property, franchises or income;
- (h) Conduct its affairs, carry on its operations, and have offices and exercise the powers granted by Florida law in any state, territory, district or possession of the United States or any foreign country;
- (i) Purchase, take, receive, lease, take by gift, devise or bequest, or otherwise acquire, own, hold, improve, use or otherwise deal in and with real or personal property, or any interest therein wherever situated.
- (j) Acquire, enjoy, utilize and dispose of patents, copyrights and trademarks and any licenses and other rights and trademarks and any licenses and other rights or interests thereunder or therein;
- (k) Sell, convey, mortgage, pledge, lease, exchange, transfer or otherwise dispose of all or any part of its property and assets;
- (1) Purchage, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge or otherwise dispose of and otherwise use and deal in and with, shares and other interests in, or obligations of, other domestic or foreign corporations, whether for profit or not for profit,

- (m) Lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested;

- (o) Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the Corporation is organized; and
- (p) Merge and consolidate with other corporations that are not for profit corporations.

ARTICLE IV

MEMBERSHIP

- (a) Trustees as Membership. The sole class of members of this Corporation shall be its trustees who may be admitted to memberships in the manner prescribed by the By-Laws of the Corporation.
- (b) Rights and Liabilities of Members. The members of this corporation shall have no right, title, or interest whatsoever in its income, property, or assets, nor shall any portion of such income, property, or assets be distributed to any member on the dissolution or winding up of this Corporation. Members of this Corporation shall not be personally liable for the debts,

liabilities, or obligations of the Corporation, and shall not be subject to any assessments.

ARTICLE V

DURATION

The Corporation shall have perpetual existence.

ARTICLE VI

MANAGEMENT

Section 1. The affairs of the Corporation shall be managed by a Board of Trustees. The Board of Trustee shall consist of not less than three (3) persons. Trustees shall be elected or removed in accordance with the procedure provided in the Bylaws.

Section 2. The officers of the Corporation shall be a President, one or more Vice Presidents and a Secretary/Treasurer. These officers shall be elected and shall hold office in the manner provided in the Bylaws of the Corporation.
