(Florida Document Number N01000005779, IRS EIN 54-2066940) certify that that by unanimous vote of all directors, the following actions were taken on May 1, 2008. The corporation has no members.

The Articles of Incorporation were amended and restated as follows:

- 1. NAME: The name of the corporation is: "Maritime & Yachting Foundation, Inc."
- 2. PRINCIPAL OFFICE: The principal office & mailing address is: 4855 SW Loch Lane, Palm City, FL 34990 4
- 3. PURPOSE; The purpose of the corporation is educational. In furtherance thereof and not in limitation, the corporation shall encourage awareness of the history and culture of the maritime and yachting community. No substantial part of the activities of the corporation shall be the carrying on propaganda, or otherwise attempting to influence legislation. The corporation shall not participate in, or intervene in (including the publishing distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activity not permitted to be carried on by an organization exempt from federal income tax under IRC Code Section 501(c)(3) or by an organization, contributions to which are deductible under IRC Code Section 170 (c)(2).
- 8. DISSOLUTION: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of IRC Code Section 501(c)(3), or shall be distributed to the federal, state or local government for a public purpose.
