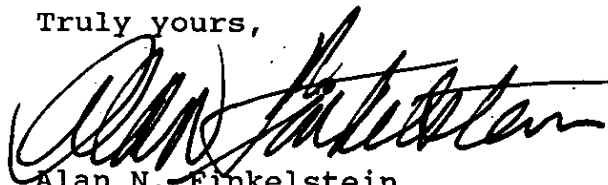
The above named non-profit organization is in receipt of your notice of Administrative Dissolution and has authorized me to respond to it. The undersigned is the corporation's registered agent.
