The undersigned being one (1) in number, hereby for the purpose of becoming a corporate body, pursuant to **Chapter 617, Florida Statutes**, does hereby certify and make, subscribe and acknowledge, and file in the Office of the Secretary of State of the State of Florida, this Certificate:

**ARTICLE I**

The name of this corporation shall be know as **FILIPINIANA CULTURAL FOUNDATION, INC.**, ~~DBA FILIPINIANA~~ <sup>C Davis</sup>, and the initial address of the corporation is 9015 Bowman Ave., Pensacola, FL 32534, and the name of the registered agent at such address is **Cereza D. Davis**.

**ARTICLE II**

The period of the duration for this corporation is perpetual, unless dissolved according to law. The corporate existence shall commence on the 25<sup>th</sup> day of July, 2001.

**ARTICLE III**

This corporation is nonprofit organized for the following purpose:

1. To promote awareness of the cultural heritage of the Filipinos through dance, song and music.
2. To provide a venue for dance instruction, rehearsals, and performances, with the focus on Philippine and Pacific Island dances.
3. To solicit, collect and receive money and other assets by donation, gift, contribution, devise and bequest or otherwise, and to hold the name in trust for the uses and purposes for which this corporation is organized.

4. The corporation shall not be used for any activity not in keeping with its true purpose and objective.

#### ARTICLE IV

The qualifications for membership and the manner of admission are written in the Constitution and by-laws of the organization. The manner in which the Officers and Board Members are to be selected is embodied in the Constitution and by-laws of the organization as well.

#### ARTICLE V
