In compliance with the requirements of Chapter 617 of the Florida Statutes, the undersigned have this day voluntarily associated themselves together for the purpose of forming a corporation not-for-profit, and do hereby certify:

ARTICLE I

Name

The name of this corporation is:

ARTICLE II

Address

ARTICLE III

Registered Agent

ARTICLE IV

Purpose

The purpose and mission of this organization shall be to honor God by leading people to become fully devoted followers of Christ.

ARTICLE V

Requirements of Membership

Each member shall be a born again believer in Jesus Christ as Savior, and be scripturally baptized by immersion.

ARTICLE VI

The officers of this organization shall be elected in the manner prescribed in the By-Laws and shall hold office for a period of one (1) year, or until their successors are duly elected and charged.

ARTICLE VII
By-Laws and Constitution

There shall be one form of Constitution and By-Laws for New Hope Community Church of Destin, Florida, Inc., which shall be the only laws by which each member shall be governed and a copy shall be furnished to each member.

It is the obligation and responsibility of each member to comply with the Constitution and By-Laws of this organization, and the orders of its proper officers when in conformity therewith; and shall refrain from conduct that tends to or is designed to interfere with the performance or duties or obligations of the members. Not only shall the Constitution and By-Laws be binding on the officers of the corporation, but likewise shall apply to any other organization who by their own acts have made themselves associates before or after the fact.

No officer or member of this organization may resort to any court of law or equity or other civil authorities either as parties or plaintiffs for the purpose of securing an opinion or decision in connection with any alleged grievance or wrong concerning any case in controversy arising within this organization or under its laws until such office or member first shall have exhausted all remedies as provided herein, not inconsistent with applicable law, for the settlement and disposition of such alleged rights, grievances or wrongs.

ARTICLE VIII
Term of Existence

The term of existence of the corporation shall be perpetual.

ARTICLE IX
Activities

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue law, or (b) a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954, or any other corresponding provision of any future United States Internal Revenue law.

ARTICLE X
Corporate Powers

This corporation shall have all of the corporate powers provided by Florida Statutes 617.021.

ARTICLE XI
Amendment

Any amendment to these Articles of Incorporation, if in conformity with the Constitution and By-Laws of New Hope Community Church of Destin, Florida, Inc., may be adopted by a two-thirds (2/3) vote of the members present at any meeting, provided written notice of the proposed amendment and date of such meeting shall have been given the members at least two (2) weeks prior thereto.
