### ARTICLE I - NAME

SECRETARY OF STATE

The name of this incorporation shall be Greendawgs Hockey Association, Inc.  
This incorporation is and shall be a non-profit organization.

### ARTICLE II - PRINCIPAL OFFICE

### ARTICLE III - PURPOSE & MISSION

The purpose of Greendawgs Hockey Association, Inc. is to provide an opportunity for all, who are interested, to participate in youth roller hockey and to develop hockey skills to each player's potential.

The primary goals of Greendawgs Hockey Association, Inc. are to educate youth participants and adult sponsors in the fundamentals of the game of roller hockey and to teach good sportsmanship. In addition, Greendawgs Hockey Association, Inc. also intends to promote the game of roller hockey through the sponsorship of regularly scheduled roller hockey competition and tournaments and to conduct any other educational activities as shall be deemed appropriate to the promotion of youth roller hockey.

The mission of the Greendawgs Hockey Association, Inc. is to build self-esteem and good character in youth roller hockey players while developing both their individual and team skills. Emphasis is placed upon having fun while inspiring youth roller hockey players to become exemplary citizens of the community.

### ARTICLE IV - MANNER OF ELECTION

Rodney Knicely, the President and founder of Greendawgs Hockey Association, Inc. appoints the directors of the corporation annually. At least one Greendawg parent from each age group represented by a team, for a minimum of three directors, who have an interest is serving on the board of directors, shall be appointed to serve as directors. In addition, one individual with professional or business experience, not otherwise affiliated with Greendawgs Hockey Association, Inc. will be invited to serve as director.

Directors are appointed in January of each year and serve through December unless they resign or are removed from their position with or without cause. The president fills vacancies that arise during the term by appointment.

With the exception of the office of President, the Board of Directors makes nominations for officers in January of each year. A majority of the vote determines the positions of Vice President, Secretary and Treasurer. Officers serve from January through December unless they resign or are removed from their respective position with or without cause.


