SMIRNA PENTECOSTAL CHURCH, INC. hereby forms a religious corporation not for profit in accordance with the provisions of Chapter 617, Florida statutes, and all amendments relating thereto and hereby adopts the following articles of incorporation:

ARTICLE I

THE NAME AND ADDRESS

The name of the corporation is **SMIRNA PENTECOSTAL CHURCH, INC.** with a physical address at 1311 Delaware Ave, Ft. Pierce, 34950

ARTICLE II

PURPOSE

The purpose of this corporation shall be to operate and maintain a church, which is true to the Bible as the infallible Word of God and the only rule of faith and practice; which is Christian in doctrine, form and government; and which serves and glorifies Jesus Christ as Lord and Living Savior throughout all functions of a church in the broadest sense.

ARTICLE III

BY WHOM AND MANNER AMENDMENTS TO THE ARTICLES OF INCORPORATION MAY BE PROPOSED AND ADOPTED

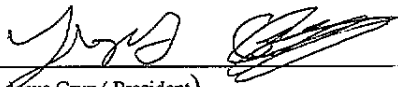

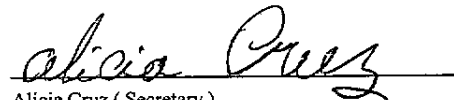
ARTICLE IX

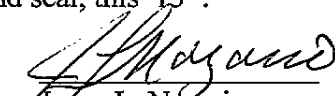
