ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be:

Central Florida Baseball, Inc.

No part of the net earnings of the corporation shall to the benefit of or be distributable to its member, officers, directors or other private persons except as reimbursement for expenses incurred on behalf of the corporation in its stated cause.

In the event of dissolution of this corporation, any remaining funds will be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION

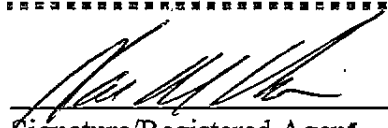

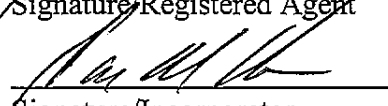
