**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
NATURAL LIFE FOR CHILDREN, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, NATURAL LIFE FOR CHILDREN, INC., a Florida not for profit corporation (the "Corporation"), hereby adopts the following amendment(s) to its Articles of Incorporation:


1. The name of the Corporation is NATURAL LIFE FOR CHILDREN, INC.
2. Article I of the Articles of Incorporation is hereby amended as follows:

"ARTICLE I

The name of the Corporation shall be: **NATURAL LIFE GIVES BACK, INC."**

3. There are no members of the Corporation. The foregoing amendment(s) was duly and unanimously adopted and approved by the board of directors on August 1, 2024.
4. Except as amended hereby, the Articles of Incorporation of the Corporation shall remain in full force and effect.
5. These Articles of Amendment shall be effective as of August 1, 2024.
