ARTICLE I
NAME

ARTICLE II
PURPOSE

DISSOLUTION**

The property of this corporaiton is irrevocably dedicated to religious purpose and no part of the net income or assets of this organization shall ever insure to the benefits of any private person. Upon dussolution of the organization assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of nay future federal tax code, or shall be distributed to the Federal, State , or local government for public purpose. any such aassets not so disposed of shall be disposed of by the Court of common Pleas in the county in ehich the principal office of the organization is then located, exclusively for such purposes.
