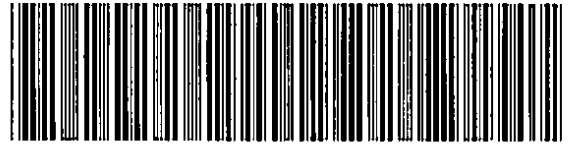

Article III - Purpose (is amended as follows):

The organization is an international Catholic lay organization, organized exclusively for charitable, religious and educational purposes, offering person to person service to needy and suffering. This organization will supply the needy with food, clothing, furnishings, limited financial aid for rent/mortgage, electric and water, motel, prescriptions, transportation and various other emergency needs. This organization assists its clients in making ends meet and moving toward an improved self-support condition through programs of change and education to improve earning potential. These services, programs and education are provided free of charge to the people served with funds donated by the general public.

Article VII - Dissolution of Organization (is being added):

Said organization is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
